The ongoing Covid-19 pandemic, the most devastating since the Great Depression, is set to drive fundamental reforms of the global socioeconomic paradigm and international architecture for years to come. There is an increasing call for a reinvention towards more sustainable and inclusive capitalism. Aside from the accelerating trend of de-globalization and digitalization, ESG (abbreviation for environmental, social, governance) has emerged as a key facilitator to promote transition towards more sustainable investment and growth in the post-Covid age.
